CHORAL COMPOSITION COMPETITION

CAPPELLA GLORIANA, SAN DIEGO'S PROFESSIONAL A CAPPELLA ENSEMBLE (8 TO 16 VOICES), HAS ISSUED A CALL FOR SCORES IN ITS FIRST CHORAL COMPOSITION COMPETITION.

FIRST PRIZE: \$1,000, A PUBLIC PERFORMANCE, AND A RECORDING
SECOND PRIZE: \$500, A PUBLIC PERFORMANCE, AND A RECORDING

ELIGIBILITY:

- I. COMPOSER MUST BE A CITIZEN OR PERMANENT RESIDENT OF NORTH, CENTRAL, OR SOUTH AMERICA, BORN AFTER DECEMBER 31, 1965.
- II. PAST OR PRESENT MEMBERS OF CAPPELLA GLORIANA ARE NOT ELIGIBLE FOR CASH PRIZES.

SUBMISSION CRITERIA:

- I. MUST BE AN ORIGINAL COMPOSITION, SUBMITTED BY THE COMPOSER, FOR SATB MIXED CHOIR, A CAPPELLA OR WITH PIANO ACCOMPANIMENT; DIVISI PERMISSIBLE, BUT MAY NOT EXCEED SSAATTBB; AT LEAST THREE (3) BUT NO MORE THAN EIGHT (8) MINUTES IN LENGTH.
- II. COMPOSITION MUST NOT HAVE BEEN PUBLICLY PREMIERED.
- III. IF THE TEXT USED IS NOT IN THE PUBLIC DOMAIN, PROOF MUST BE PROVIDED THAT COMPOSER HAS PERMISSION TO SET THE TEXT.
- IV. SCORES MUST BE SUBMITTED ANONYMOUSLY, WITH ALL NAMES AND IDENTIFYING MARKS REMOVED. A COVER SHEET CONTAINING COMPOSER'S NAME, ADDRESS, E-MAIL ADDRESS AND PHONE NUMBER MUST BE INCLUDED. IF COMPOSER WISHES THE SCORE TO BE RETURNED, HE/SHE MUST INCLUDE A SELF-ADDRESSED STAMPED ENVELOPE FOR THAT PURPOSE.
- V. SCORES MUST BE LEGIBLE, AND A PIANO REDUCTION OF VOCAL PARTS SHOULD BE PROVIDED, IF PRACTICAL.
- VI. A CHECK OR MONEY ORDER FOR \$10 IN US FUNDS, MADE OUT TO "CAPPELLA GLORIANA, INC." MUST BE INCLUDED WITH SUBMISSION.
- VII. PROOF OF COMPOSER'S AGE AND CITIZENSHIP/RESIDENCY IN THE AMERICAS WILL BE REQUIRED OF THE WINNERS.

DEADLINE, EVALUATION, AND NOTIFICATION:

- I. SUBMISSIONS MUST BE POSTMARKED NO LATER THAN MAY 1, 2006.
- II. SCORES WILL BE REVIEWED BY A PANEL INCLUDING THREE NATIONALLY RECOGNIZED AMERICAN COMPOSERS, WHOSE DECISIONS WILL BE FINAL.
- III. THE JUDGES' DECISION WILL BE ANNOUNCED AUGUST 1, 2006, AND ALL ENTRANTS WILL BE NOTIFIED FOLLOWING THAT ANNOUNCEMENT.
- IV. WINNING COMPOSITIONS WILL BE PREMIERED IN A CONCERT BY CAPPELLA GLORIANA IN SAN DIEGO, CALIFORNIA IN NOVEMBER 2006. COMPOSERS AGREE TO ALLOW CAPPELLA GLORIANA THE RIGHT TO PERFORM AND/OR RECORD THE WINNING COMPOSITIONS WITHOUT PAYMENT OF ROYALTIES OR OTHER FEES (OTHER THAN THE PRIZE MONEY) FOR A PERIOD OF TWO YEARS (Nov. 2006 to Nov. 2008).
